

## Time-dependent semi-discrete analysis of the viscoelastic fluid flow problem using a variational multiscale stabilised formulation

In this article we analyse a stabilised finite element formulation recently proposed to approximate viscoelastic fluid flows. The formulation has shown to have accuracy and robustness in the different benchmarks tested in the viscoelastic framework and permitting the use of equal interpolation of the unknown fields. We first present results about a linearised sub-problem, for which well-posedness and stability results can be proved. Then, the semi-discrete nonlinear time-dependent case is addressed using a fixed point theorem, which allows us to prove existence of a semi-discrete solution, along with error estimates.

*Keywords:* Viscoelastic fluids; stabilised finite element methods; time-dependent flows

### 1. Introduction

Viscoelastic fluids are a specific type of non-Newtonian fluids. They are characterized by having complex and high-molecular-weight molecules with many internal degrees of freedom (Bird *et al.* (2002)). The classical examples of this type of fluids are the polymer solutions and molten polymers. The basic feature of polymeric fluids is the presence of long chain molecules. In a flow, these chain molecules are stretched out by the drag forces exerted on them by the surrounding fluid (Renardy (1989)). The natural tendency of the molecule to retract from this stretched configuration generates an elastic force which contributes to the macroscopic stress tensor, and for this reason they are called viscoelastic fluids. The interest for fluids of this kind has increased in the last years, due to the connections with the industrial applications. This motivates the numerical and mathematical analysis of the governing equations (see, e.g., Fernández-Cara *et al.* (2002)).

For viscoelastic fluid flows, in contrast to the Navier-Stokes equations, well-posedness for general models is not well understood. For initial value problems, the existence of solutions has been proved only locally in time. Global existence in time of solutions has been proved only if the initial conditions

are small perturbations of the rest state, and for the steady state case existence of solutions can be proved only for small perturbations of the Newtonian case (see Renardy (1989) for a comprehensive review).

The existence of slow steady flows of viscoelastic fluids using differential constitutive equations was proved in Renardy (1985) for Hilbert spaces. In this work, the author used an iterative method to show that the solution can be bounded in a certain norm, and then he proved that all iterates converge in a weaker norm. For the time-dependent case, existence of solutions locally in time, and for small data globally in time, has been proved for Hilbert spaces in Guillopé & Saut (1990). The extension to Banach spaces and a complete review of uniqueness, regularity, well-posedness and stability results can be found in Fernández-Cara *et al.* (2002). The existence of global weak solutions for general initial conditions using a co-rotational Oldroyd-B model has been proved in Lions & Masmoudi (2000) using a simplification (without physical justification) which consists in replacing the velocity gradient in the stress equation by its skew-symmetric part. In Barrett & Boyaval (2011) the authors proved global existence of weak solutions in two dimensions to the Oldroyd-B model regularised with the introduction of a diffusion term in the constitutive equation and assuming homogeneous natural boundary conditions associated to this term. The proof in this paper is based on a mixed finite element interpolation of the problem. The introduction of the stress diffusion can be physically justified. An analysis of the effects it has on the numerical approximation can be found in Sureshkumar & Beris (1995).

From a finite element perspective, the finite element approximation of the flow of viscoelastic fluids presents several numerical difficulties. One the one hand, there are all the problems inherited from the incompressible Navier-Stokes equations, mainly the compatibility between the velocity-pressure approximation and the treatment of the nonlinear advective term. But, on top of that, now the constitutive equation is highly nonlinear, with an advective term that may lead to both global and local oscillations in the numerical approximation. Moreover, even in the case of smooth solutions it is necessary to meet some additional compatibility conditions between the velocity and the stress interpolation in order to control velocity gradients. Elements that satisfy the compatibility requirements velocity-pressure and stress-velocity are scarce, particularly in the three-dimensional case (see, e.g., Marchal & Crochet (1987); Fortin & Fortin (1989); Bogaerds *et al.* (1999)). In Baaijens (1998) one can find a good review of mixed methods that satisfy the two required compatibility conditions.

In the finite element framework, the work of Baranger & Sandri (1992) was one of the first where the existence of an approximate solution and error bounds were given for an Oldroyd-B fluid, using Brouwer's fixed point theorem, discontinuous interpolation for the elastic stresses and the method of Lesaint-Raviart for the convection of the extra stress tensor in the stationary case. Later, Sandri extended (Sandri (1994)) the study to continuous approximation of the stress field, using  $P_1$ - $P_2$ - $P_1$  interpolation (linear-quadratic-linear) for  $\sigma$  (stress),  $u$  (velocity) and  $p$  (pressure), respectively, and the SUPG method to treat the convective term in the constitutive equation. The time-dependent case of the same continuous interpolation was analysed in Baranger & Wardi (1995).

In the same finite element context, Picasso & Rappaz (2001) analysed a stationary non-convective Oldroyd-B problem proving a priori and a posteriori error estimates. In this work, the authors used the Galerkin Least Squares (GLS) method to stabilise the momentum equation and the Elastic Viscous Split Stress (EVSS) scheme for the constitutive equation. The extension to the time-dependent case was treated in Bonito *et al.* (2007) for the same simplified Oldroyd-B problem, proving global existence in time in Banach spaces for small data. For a Stokes/Oldroyd-B linearised problem, Bonito & Burman (2007) presented optimal a priori error estimates using the Interior-Penalty method. A similar problem was studied in Ervin *et al.* (2005) for the steady state case but using the Johnson-Segalman linearised constitutive model, proving existence and uniqueness of the continuous solution and of a finite element approximation under a small data assumption. In another work, Ervin & Miles (2003) analysed the

Oldroyd-B time-dependent case both in the semi-discrete and in the fully discrete cases using the SUPG method, and proving existence of a solution and deriving a priori error estimates for the numerical approximation, assuming a Taylor-Hood pair approximation for the velocity and pressure and a continuous approximation for the viscoelastic stresses. The same authors extended later the analysis to a two-fluid flow problem in Ervin & Miles (2005), giving a priori error estimates for the approximation in terms of the mesh and time discretization parameters. In Pani & Yuan (2005) the authors analysed the time behaviour of the viscoelastic Oldroyd model in two dimensions using a Galerkin formulation in space; in this work, the stress is eliminated through a proper projection operator, resulting in an integro-differential equation in terms of velocity and pressure.

The stabilised finite element formulation analysed in this work has its roots in the Variational Multiscale (VMS) method introduced in Hughes *et al.* (1998) for the scalar convection-diffusion-reaction problem, and extended later to the Stokes problem in Codina (2000), where the space of the sub-grid scales is taken orthogonal to the finite element space. As we shall see, this is an important ingredient in the method analysed, which consists in a sort of orthogonal term-by-term stabilised formulation. The key idea behind a VMS method consists in splitting the unknowns of the problem in two scales, the finite element one and the unresolvable one, called sub-grid scale. The latter needs to be approximated in a simple manner in terms of the former, so as to capture its main effect and yield a globally stable formulation for the finite element unknown, keeping therefore the number of degrees of freedom of the Galerkin method.

The objective of this paper is to analyse numerically the stabilised finite element formulation proposed in Castillo & Codina (2014b) for the time-dependent viscoelastic flow problem. This formulation has shown to have very good accuracy and robustness in stationary (Castillo & Codina (2014b)) and time-dependent (Castillo *et al.* (2015); Castillo & Codina (2015)) cases. The numerical analysis of a linearised stationary case was performed in Castillo & Codina (2017b), where in addition jump functions were added to permit arbitrary discontinuous interpolations of pressure and stresses. As it is usual in the analysis of numerical approximations to flow problems, even in the Newtonian case, our analysis is based on some stringent regularity assumptions on the continuous solution. Apart from analysing a non-standard stabilised formulation, the novelty of this work is also the treatment of some of the terms that appear in the analysis.

The work is organised as follows. Section 2 defines some notation and presents general results used in the subsequent analysis. In Section 3 we present the problem to be solved and its Galerkin finite element approximation, explaining the sources of the numerical instability. Section 4 contains a description of the stabilised finite element formulation analysed. Section 5 is devoted to the numerical analysis of a linearised time-dependent subproblem, where the stability of the method and the existence and uniqueness of the solution in the semi-discrete linearised case are proved. Section 6 analyses the non-linear case, where existence of a solution is proved using a fixed point theorem. Finally, conclusions and some remarks are summarised in Section 7.

## 2. Notation and preliminaries

### 2.1 Notation

Let us introduce some notation used hereafter. As usual, given a domain  $\omega$  of  $\mathbb{R}^d$ ,  $d = 2, 3$ ,  $W^{m,p}(\omega)$  denotes the Sobolev space of functions whose distributional derivatives of order up to  $m \in \mathbb{N}$  belong to  $L^p(\omega)$ ,  $p \geq 1$ , endowed with the standard norm. For  $p = 2$  we write  $W^{m,2}(\omega) \equiv H^m(\omega)$ . The space  $H_0^1(\omega)$  consists of functions in  $H^1(\omega)$  vanishing on  $\partial\omega$ . The topological dual of  $H_0^1(\omega)$  is denoted by  $H^{-1}(\omega)$ , the corresponding duality pairing by  $\langle \cdot, \cdot \rangle_\omega$ , and the  $L^2$  inner product in  $\omega$  (for scalars, vectors

and tensors) is denoted by  $(\cdot, \cdot)_\omega$ . The symbol  $\langle \cdot, \cdot \rangle_\omega$  is also used for the integral over  $\omega$  of the product of two functions, whenever it makes sense. When  $\omega = \Omega$ , the domain where the problem is posed, the subscript or the domain information are omitted. Referring to the norms used in the subsequent analysis,  $\|\cdot\|$  represents the  $L^2(\Omega)$ -norm,  $\|\cdot\|_{L^p}$  the  $L^p(\Omega)$ -norm ( $2 < p < \infty$ ),  $\|\cdot\|_\infty$  the  $L^\infty(\Omega)$ -norm,  $\|\cdot\|_k$  the  $H^k(\Omega)$ -norm,  $\|\cdot\|_{L^1,p}$  the norm for the space  $W^{1,p}(\Omega)$  (in particular,  $\|\cdot\|_{1,\infty}$  is the  $W^{1,\infty}(\Omega)$ -norm) and  $|\cdot|_{L^1,p}$  the semi-norm.

The symbol  $\lesssim$  will be used for  $\leq$  up to constants independent of the physical parameters and the parameters of the numerical discretization. Given a vector field  $v$ , its symmetrical gradient will be denoted by  $\nabla^s v$ ; it is defined as

$$\nabla^s v = \frac{1}{2} \left( \nabla v + (\nabla v)^T \right).$$

Finally, the temporal derivative will be written as  $\partial_t$ .

## 2.2 Preliminaries

Let us introduce some basic results. The gradient of a vector field  $v$  can be bounded in terms of its symmetrical gradient as Ciarlet (2013):

$$\|\nabla v\| \leq \sqrt{2} \|\nabla^s v\|, \quad v \in (H_0^1(\Omega))^d.$$

Poincaré-Friedrich's and Korn's inequalities read as: for  $v \in (H_0^1(\Omega))^d$ , there exists constants  $c_{\text{PF}}$  and  $c_\Omega$  such that

$$\|v\| \leq c_{\text{PF}} \|\nabla v\|, \quad \|v\|_1 \leq c_K \|\nabla^s v\|.$$

From the Sobolev embedding theorems (see Girault & Raviart (1986), for example), we can bound the  $L^4(\Omega)$ -norm in terms of the  $H^1(\Omega)$ -norm as follows:

$$\|v\|_{L^4} \leq C_{04}^{12} \|v\|_1. \quad (2.1)$$

Constants  $c_{\text{PF}}$ ,  $c_K$  and  $C_{04}^{12}$  depend on the shape and size of the domain  $\Omega$ . We will use  $c_{\text{PF}}$  as the constant to bound the  $L^2(\Omega)$ -norm of a function by its  $H^1(\Omega)$ -norm.

For the finite element formulation that we shall consider, the discrete velocity field will not be point-wise divergence free and the use of the skew-symmetric counterpart of the convective term simplifies the subsequent analysis. Then, for  $u, v, w \in (H_0^1(\Omega))^d$  we define

$$\tilde{c}(w, u, v) = \frac{1}{2} (c(w, u, v) - c(w, v, u)), \quad \text{with} \quad c(w, u, v) = \langle w \cdot \nabla u, v \rangle.$$

The following properties are satisfied by this skew-symmetric form:

1.  $\tilde{c}(w, u, v) = c(w, u, v)$  when  $\nabla \cdot w = 0$  and either  $w = 0$  or  $u = 0$  or  $v = 0$  on  $\partial\Omega$ .
2.  $\tilde{c}(w, u, u) = 0$ ,  $w, u \in (H^1(\Omega))^d$ .
3.  $\tilde{c}(w, u, v) \leq (C_{04}^{12})^2 \|w\|_1 \|u\|_1 \|v\|_1$ ,  $w, u, v \in (H^1(\Omega))^d$ .
4.  $\tilde{c}(w, u, v) \leq \|w\|_\infty (\|u\|_1 \|v\|_1 + \|u\| \|v\|_1)$ ,  $w \in (L^\infty(\Omega))^d$ ,  $u, v \in (H^1(\Omega))^d$ .
5.  $\tilde{c}(w, u, v) \leq \|v\| (\|u\|_\infty \|\nabla w\| + \|\nabla u\|_\infty \|w\|)$ ,  $w \in (H_0^1(\Omega))^d$ ,  $u \in (W^{1,\infty}(\Omega))^d$ ,  $v \in (L^2(\Omega))^d$ .

$$6. \quad \tilde{c}(w, u, v) \leq \|v\|(\|u\| \|\nabla w\|_\infty + \|\nabla u\| \|w\|_\infty), \quad w \in (W^{1,\infty}(\Omega))^d, \quad u \in (H_0^1(\Omega))^d, \quad v \in (L^2(\Omega))^d.$$

Integration by parts has to be used to prove the last two properties. The same definition of the trilinear forms  $c$  and  $\tilde{c}$  and with the same properties can be introduced when the last two arguments are tensor-valued and with the appropriate regularity.

Let us consider a finite element partition  $\mathcal{T}_h = \{K\}$  of the computational domain  $\Omega$ . The diameter of an element domain  $K \in \mathcal{T}_h$  is denoted by  $h_K$  and the diameter of the partition, or mesh size, is defined as  $h = \max\{h_K \mid K \in \mathcal{T}_h\}$ . We will consider for simplicity quasi-uniform families of meshes, and thus all the element diameters can be bounded above and below by constants multiplying  $h$ .

Defining  $V_h := \{v_h : \Omega \rightarrow \mathbb{R} \mid v_h|_K \in P_k(K) \forall K \in \mathcal{T}_h\}$ ,  $P_k(K)$  being the set of polynomials of degree  $k$  in  $K$ , we can write the following inverse inequality: there is a constant  $c_{\text{inv}}$ , independent of the mesh size  $h$ , such that

$$\|v_h\|_{l,p,K} \leq c_{\text{inv}} h^{m-l+\min(0, \frac{d}{p}-\frac{d}{q})} \|v_h\|_{m,q,K}, \quad (2.2)$$

for all  $l \geq m, l \in [1, +\infty]$ , and all finite element functions  $v_h$  defined on  $K \in \mathcal{T}_h$  (see Ern & Guermond (2004), for example), where  $\|v_h\|_{l,p,K}$  is the norm of  $v_h$  in  $W^{l,p}(K)$ .

For  $v \in W^{l,p}(\Omega)$  we have the following interpolation estimate: there exists a constant  $C$  independent of  $h$ , such that for all  $0 \leq l \leq k+1, 1 \leq p \leq \infty$ , there holds

$$\|v - P[v]\|_{L^p} \leq Ch^l |v|_{l,p}, \quad (2.3)$$

where  $P[v] \in V_h$  is the  $L^2(\Omega)$ -projection of  $v$  in  $V_h$  (see Ern & Guermond (2004) for more details). From Sobolev's embedding and the stability of  $P$  on finite element spaces we also have that

$$\|\nabla(v - P[v])\|_\infty \leq C_{\infty,3} \|v\|_3, \quad (2.4)$$

where  $C_{\infty,3}$  is a positive constant independent of  $h$ .

### 3. Problem statement and Galerkin finite element discretization

#### 3.1 The boundary value problem

Let  $\Omega$  be an open set of  $\mathbb{R}^d$  occupied by the fluid, assumed to be bounded and polyhedral, and let  $\partial\Omega$  be its boundary. Additionally, consider the time interval  $]0, T[$ , with  $T < \infty$ . The incompressible and isothermal viscoelastic fluid flow problem can be written as:

$$\rho(\partial_t u + u \cdot \nabla u) - \nabla \cdot (2\beta\mu \nabla^s u + \sigma) + \nabla p = f \quad \text{in } \Omega, t \in ]0, T[, \quad (3.1)$$

$$\nabla \cdot u = 0 \quad \text{in } \Omega, t \in ]0, T[, \quad (3.2)$$

$$\begin{aligned} \frac{1}{2\mu} \sigma - (1-\beta) \nabla^s u + \frac{\lambda}{2\mu} (\partial_t \sigma + u \cdot \nabla \sigma) \\ - \frac{\lambda}{2\mu} (\sigma \cdot \nabla u + (\nabla u)^T \cdot \sigma) = 0 \quad \text{in } \Omega, t \in ]0, T[, \end{aligned} \quad (3.3)$$

$$u = 0 \quad \text{on } \partial\Omega, t \in ]0, T[, \quad (3.4)$$

$$u|_{t=0} = u_0 \quad \text{in } \Omega, \quad (3.5)$$

$$\sigma|_{t=0} = \sigma_0 \quad \text{in } \Omega. \quad (3.6)$$

The unknowns of the problem are: the velocity field  $u(x, t)$ , the pressure  $p(x, t)$  and the viscoelastic or elastic part  $\sigma(x, t)$  of the extra stress tensor. The physical parameters are the dynamic viscosity  $\mu$ , the density of the fluid  $\rho$ , a real parameter  $\beta \in [0, 1]$  to define the amount of viscous or solvent viscosity ( $\mu_s = \beta\mu$ ) and elastic or polymeric viscosity ( $\mu_p = (1 - \beta)\mu$ ) in the fluid, and the relaxation time  $\lambda$ , that represents the elasticity of the fluid. Finally,  $f \in (H^{-1}(\Omega))^d$  is the external volume force applied to the fluid confined in  $\Omega$ .

For viscoelastic fluids, the problem is incomplete without the definition of a constitutive equation for the elastic stresses ( $\sigma$ ). A large variety of approaches exist to define it (see Bird *et al.* (1987a,b) for a complete description). In this work, we use the classical Oldroyd-B constitutive model (3.3) for this purpose.

The conservation laws (3.1)-(3.2) together with the Oldroyd-B constitutive equation (3.3) are a mixed parabolic-hyperbolic problem, that needs to be complemented with initial (3.5)-(3.6) and boundary (3.4) conditions to close the problem. For simplicity in the exposition, we will consider the simplest boundary condition for the velocity and no boundary conditions for the stress field. With respect to the initial conditions,  $u_0$  and  $\sigma_0$  are functions defined on the whole domain  $\Omega$ . For a complete description of the mathematical structure of the problem we refer to Fernández-Cara *et al.* (2002); Renardy (1989).

### 3.2 Variational form

To write the weak form of problem (3.1)-(3.3) we need to introduce some functional spaces. Let  $\mathcal{V} = (H_0^1(\Omega))^d$ ,  $\mathcal{Y} := \{ \tau \mid \tau \in (L^2(\Omega))_{\text{sym}}^{d \times d}, w \cdot \nabla \tau \in (L^2(\Omega))_{\text{sym}}^{d \times d} \forall w \in \mathcal{V} \}$  (subscript sym standing for symmetric tensors) and  $Q = L^2(\Omega)/\mathbb{R}$ , the spaces of the velocity, the elastic stresses and the pressure, respectively. If we denote  $U := (u, p, \sigma)$ ,  $\mathcal{X} := \mathcal{V} \times Q \times \mathcal{Y}$ , the weak form of the problem consists in finding  $U : ]0, T[ \rightarrow \mathcal{X}$  such that the initial conditions are satisfied and

$$\rho(\partial_t u, v) + \rho(u \cdot \nabla u, v) + (2\beta\mu \nabla^s u + \sigma, \nabla^s v) - (p, \nabla \cdot v) = \langle f, v \rangle, \quad (3.7)$$

$$(\nabla \cdot u, q) = 0, \quad (3.8)$$

$$\left( \frac{1}{2\mu} \sigma - (1 - \beta) \nabla^s u, \tau \right) + \frac{\lambda}{2\mu} (\partial_t \sigma + u \cdot \nabla \sigma, \tau) - \frac{\lambda}{2\mu} (g(u, \sigma), \tau) = 0, \quad (3.9)$$

for all  $V = (v, q, \tau) \in \mathcal{X}$ . The last term of the constitutive equation represents the traction or rotational term, defined as  $g(u, \sigma) := \sigma \cdot \nabla u + (\nabla u)^T \cdot \sigma$ .

In a compact form, problem (3.7)-(3.9) can be written as:

$$(\mathcal{D}_t(U), V) + B(u, \sigma; U, V) = \langle f, v \rangle, \quad (3.10)$$

for all  $V \in \mathcal{X}$ , where

$$\begin{aligned} B(\hat{u}, \hat{\sigma}; U, V) &= \rho(\hat{u} \cdot \nabla u, v) + 2\beta\mu (\nabla^s u, \nabla^s v) + (\sigma, \nabla^s v) - (p, \nabla \cdot v) + (\nabla \cdot u, q) \\ &+ \frac{1}{2\mu} (\sigma, \tau) - (1 - \beta) (\nabla^s u, \tau) + \frac{\lambda}{2\mu} (\hat{u} \cdot \nabla \sigma, \tau) - \frac{\lambda}{2\mu} (g(\hat{u}, \hat{\sigma}), \tau), \end{aligned} \quad (3.11)$$

and

$$(\mathcal{D}_t(U), V) := \rho(\partial_t u, v) + \frac{\lambda}{2\mu} (\partial_t \sigma, \tau). \quad (3.12)$$

### 3.3 Galerkin finite element discretization

From  $\mathcal{T}_h$  we may construct conforming finite element spaces for the velocity, the pressure and the elastic stress,  $\mathcal{V}_h \subset \mathcal{V}$ ,  $Q_h \subset Q$  and  $\Upsilon_h \subset \Upsilon$ , respectively. Denoting  $\mathcal{X}_h = \mathcal{V}_h \times Q_h \times \Upsilon_h$ , the Galerkin finite element approximation of problem (3.10) consists in finding  $U_h : ]0, T[ \rightarrow \mathcal{X}_h$  such that

$$(\mathcal{D}_t(U_h), V_h) + B(u_h, \sigma_h; U_h, V_h) = \langle f, v_h \rangle, \quad (3.13)$$

for all  $V_h \in \mathcal{X}_h$ , and satisfying the appropriate initial conditions.

Until now, we have posed no restrictions on the choice of the finite element spaces. However, let us analyse the numerical stability of problem (3.13). If we take  $V_h = U_{h1} = ((1 - \beta)u_h, (1 - \beta)p_h, \sigma_h)$ , it is found that

$$B(u_h, \sigma_h; U_h, U_{h1}) = 2(1 - \beta)\beta\mu \|\nabla^s u_h\|^2 + \frac{1}{2\mu} \|\sigma_h\|^2 - \frac{\lambda}{2\mu} (g(u_h, \sigma_h), \sigma_h). \quad (3.14)$$

It is seen from (3.14) that  $B$  is not coercive in  $\mathcal{X}_h$ , and we can ensure only control on  $\|\sigma_h\|$  for all  $\beta$  assuming  $\lambda \nabla u_h$  to be small enough.

To ensure the control of  $p_h$  and  $\nabla^s u_h$ , one has then to choose finite element spaces satisfying:

$$\inf_{q_h \in Q_h} \sup_{v_h \in \mathcal{V}_h} \frac{(q_h, \nabla \cdot v_h)}{\|v_h\|_{\mathcal{V}_h} \|q_h\|_{Q_h}} \geq C_1, \quad (3.15)$$

$$\inf_{v_h \in \mathcal{V}_h} \sup_{\tau_h \in \Upsilon_h} \frac{(\tau_h, \nabla^s v_h)}{\|\tau_h\|_{\Upsilon_h} \|v_h\|_{\mathcal{V}_h}} \geq C_2, \quad (3.16)$$

where  $C_1$  and  $C_2$  are positive constants. It is therefore required that the finite element spaces satisfy (3.15) and (3.16), which is a stringent requirement inherited from the mixed form of the Navier-Stokes problem (Castillo & Codina (2014a)).

The two compatibility conditions of the viscoelastic flow problem do not allow us the use of an arbitrary interpolation for the different fields because the scheme may become unstable. The implementation of inf-sup stable elements is a possible solution for this problem; however, from the numerical point of view, the spaces that fulfill these conditions are limited and complex, particularly when the problem needs to be solved in three dimensions. The other possibility is to use a stabilised formulation that permits the use of any interpolation for the variables, which is the approach studied in this work. Note that the constitutive equation is of convective nature, and therefore, some kind of stabilisation technique has to be used even if inf-sup stable elements are used, and likewise for the momentum equation.

## 4. Stabilised finite element method

In general, a stabilised formulation consists of replacing  $B$  in (3.10) by another multilinear form  $B_{\text{stab}}$ , possibly mesh dependent, designed to enhance stability without upsetting accuracy. The formulation we analyse, proposed in Castillo & Codina (2014b), is described next.

For the sake of conciseness, let us consider equal order *continuous* interpolation for all variables. The case of discontinuous pressures and stresses can be treated using the technique employed in Castillo & Codina (2017b). Thus, let us consider  $\mathcal{X}_h = \mathcal{V}_h \times Q_h \times \Upsilon_h$ , where  $\mathcal{V}_h = [V_h \cap H_0^1(\Omega)]^d$ ,  $Q_h = [V_h \cap \mathcal{C}^0(\Omega)]/\mathbb{R}$  and  $\Upsilon_h = [V_h \cap \mathcal{C}^0(\Omega)]_{\text{sym}}^{d \times d}$ . The method consists in replacing (3.13) by the following problem: find  $U_h : ]0, T[ \rightarrow \mathcal{X}_h$  such that

$$(\mathcal{D}_t(U_h), V_h) + B_{\text{stab}}(u_h, \sigma_h; U_h, V_h) = \langle f, v \rangle, \quad (4.1)$$

for all  $V_h \in \mathcal{X}_h$ , where

$$B_{\text{stab}}(\hat{u}_h, \hat{\sigma}_h; U_h, V_h) = B(\hat{u}_h, \hat{\sigma}_h; U_h, V_h) + B^*(\hat{u}_h, \hat{\sigma}_h; U_h, V_h), \quad (4.2)$$

and  $B^*$  represents the additional stabilisation terms added to the Galerkin formulation. Using the same notation as in Castillo & Codina (2014b), we can define  $B^*$  as

$$B^*(\hat{u}_h, \hat{\sigma}_h; U_h, V_h) = S_1^\perp(\hat{u}_h; U_h, V_h) + S_2^\perp(U_h, V_h) + S_3^\perp(\hat{u}_h, \hat{\sigma}_h; U_h, V_h),$$

where

$$\begin{aligned} S_1^\perp(\hat{u}_h; U_h, V_h) &= \alpha_u(\hat{u}_h) \left( P_u^\perp[\rho \hat{u}_h \cdot \nabla u_h], P_u^\perp[\rho \hat{u}_h \cdot \nabla v_h] \right) + \alpha_u(\hat{u}_h) \left( P_u^\perp[\nabla p_h], P_u^\perp[\nabla q_h] \right) \\ &\quad + \alpha_u(\hat{u}_h) \left( P_u^\perp[\nabla \cdot \sigma_h], P_u^\perp[(1-\beta)\nabla \cdot \tau_h] \right), \end{aligned} \quad (4.3)$$

$$S_2^\perp(U_h, V_h) = \alpha_p(\hat{u}_h) \left( P_p^\perp[\nabla \cdot u_h], P_p^\perp[\nabla \cdot v_h] \right), \quad (4.4)$$

$$\begin{aligned} S_3^\perp(\hat{u}_h, \hat{\sigma}_h; U_h, V_h) &= \alpha_\sigma(\hat{u}_h) \left( P_\sigma^\perp \left[ -(1-\beta)\nabla^s u_h + \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla \sigma_h - g(\hat{u}_h, \hat{\sigma}_h)) \right], \right. \\ &\quad \left. P_\sigma^\perp \left[ -\nabla^s v_h + \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla \tau_h + g^*(\hat{u}_h, \tau_h)) \right] \right), \end{aligned} \quad (4.5)$$

and  $g^*(\hat{u}_h, \tau_h)$ , represents the adjoint operator of  $g(\hat{u}_h, \tau_h)$ , defined as  $g^*(\hat{u}_h, \tau_h) := \tau_h \cdot (\nabla \hat{u}_h)^T + \nabla \hat{u}_h \cdot \tau_h$ . Here  $P_u^\perp = I - P_u$ , where  $P_u : L^2(\Omega) \rightarrow \mathcal{V}_h$  is the  $L^2(\Omega)$ -projection onto  $\mathcal{V}_h$ , the velocity space without boundary conditions, and  $P_p^\perp$  and  $P_\sigma^\perp$  are defined in an analogous way. We will also need  $P_{u,0} := L^2(\Omega) \rightarrow \mathcal{V}_h$ , that is to say, the  $L^2(\Omega)$ -projection onto the velocity space with boundary conditions.

Note that all the stabilisation terms in (4.3)-(4.5) are multiplied by  $\alpha_i$ ,  $i = u, p, \sigma$ . These terms are the components of the stabilisation parameter matrix, that can be defined as

$$\alpha = \text{diag}(\alpha_u I_d, \alpha_p, \alpha_\sigma I_{d \times d}),$$

where

$$\alpha_u(\hat{u}_h) = \left[ c_1 \frac{\mu}{h^2} + c_2 \frac{\rho \|\hat{u}_h\|_\infty}{h} \right]^{-1}, \quad (4.6)$$

$$\alpha_p(\hat{u}_h) = \frac{h^2}{c_1 \alpha_u(\hat{u}_h)}, \quad (4.7)$$

$$\alpha_\sigma(\hat{u}_h) = \left[ c_3 \frac{1}{2\mu} + \frac{\lambda}{2\mu} \left( c_4 \frac{\|\hat{u}_h\|_\infty}{h} + 2c_5 \|\nabla \hat{u}_h\|_\infty \right) \right]^{-1}, \quad (4.8)$$

where  $c_i$ ,  $i = 1, 2, 3, 4, 5$ , are algorithmic constants and  $I_d$  and  $I_{d \times d}$  are respectively the second and fourth order identity tensors. A general approach to design the terms of the stabilisation parameter matrix was proposed in Codina (2009) for the three-field Stokes problem. In this work, it is shown that the parameters can be uniquely determined by dimensionality, assuming that this matrix is diagonal. In general, to get optimal control the stabilisation parameters need to be evaluated element-wise (or even point-wise). The constant expression adopted in this work allows us to simplify the analysis.

The stabilising mechanisms introduced by the terms  $S_1^\perp$ ,  $S_2^\perp$  and  $S_3^\perp$  are the following. The first component of  $S_1^\perp$  gives control on the convective term, the second component gives control on the



pressure gradient, and the third term gives control on the divergence of the viscoelastic stress. The term  $S_2^\perp$  is not a must but in some cases it improves stability of the problem. Finally, the term  $S_3^\perp$  adds stability in the constitutive equation. Note that some of the components of this last term are the convective-convective term of the viscoelastic stress tensor and an equivalent EVSS-structure component, among other cross local inner-product terms (see Castillo & Codina (2014b) for more details of this spatial stabilised formulation). The addition of these three terms permits the approximation of convection dominated problems both in velocity and in stress, and the implementation of equal order interpolation for all the unknowns. The orthogonal projections introduce consistency errors, but of optimal order, a key point in the design of accurate non-residual based methods. For stationary problems, the resulting formulation turns out to have optimal order of convergence, as checked numerically in Castillo & Codina (2014b) for linear and quadratic elements.

The term-by-term form of  $S_1^\perp$  was proposed instead of a residual-based one, because the former shows a better numerical behaviour in problems where high gradients in pressure and stress are present (see Castillo & Codina (2017a) for more details about this fact).

We will need a condition on the interpolating spaces that holds in the case of equal order interpolations (see Codina & Blasco (2000)), and that can be written as follows: given  $a_h, v_h \in \mathcal{V}_h$ ,  $q_h \in \mathcal{Q}_h$ ,  $\tau_h \in \mathcal{I}_h$  and  $z_h := \rho a_h \cdot \nabla v_h + \nabla q_h - \nabla \cdot \tau_h$ , there holds

$$\|z_h\| \leq c_m \left( \|P_{u,0}(z_h)\| + \|P_u^\perp(z_h)\| \right), \quad (4.9)$$

for a constant  $c_m > 0$ . According to this condition, the component of  $P_u(z_h)$  that corresponds to the boundary of  $\Omega$  can be bounded in terms of the right-hand-side (RHS) of Eq. (4.9). To prove this, one can use the macro-element technique employed in Codina & Blasco (2000).

## 5. Linearised time-dependent case

The numerical analysis of the stabilised formulation presented in this work is divided in two steps. In this Section we present the stability analysis of the linearised case. The second part (Section 6), is devoted to the nonlinear analysis.

### 5.1 Linearised stabilised semi-discrete problem

The equations for incompressible viscoelastic flows have several nonlinear terms, both in the momentum and in the constitutive equation. In the former we have the convective term, and in the latter we have the term corresponding to the convection of stresses and the rotational term arising from the objective derivative of stresses. On top of that, the stabilisation terms depend also on the velocity, introducing therefore additional nonlinearities.

As it is usual for incompressible flow problems, for the convective term of the momentum equation we can use a Picard scheme as linearisation technique, taking the advection velocity as the velocity of the previous iteration. This leads only to first order convergence, but it is a robust option. The constitutive equation is rather more complex and sometimes the implementation of combined algorithms is recommended. See for example the work Castillo & Codina (2014b), where a Newton scheme was combined with a continuation method, or the work Howell (2009), where different types of continuation methods were proposed. For simplicity in the numerical analysis, we will use only the fixed point scheme for all the nonlinear terms, including the terms associated to the matrix of stabilisation parameters  $\alpha$ . Therefore, we analyse the following semi-discrete linearised problem: given  $\hat{u}_h : ]0, T[ \rightarrow \mathcal{V}_h$  and

$\hat{\sigma}_h : ]0, T[ \rightarrow \mathcal{Y}_h$ , find  $U_h : ]0, T[ \rightarrow \mathcal{X}_h$  such that

$$\begin{aligned} & \rho (\partial_t u_h, v_h) + \rho \tilde{c}(\hat{u}_h, u_h, v_h) + (2\beta\mu \nabla^s u_h + \sigma_h, \nabla^s v_h) - (p_h, \nabla \cdot v_h) \\ & + \alpha_u \left( P_u^\perp [\rho \hat{u}_h \cdot \nabla u_h], P_u^\perp [\rho \hat{u}_h \cdot \nabla v_h] \right) + \alpha_p \left( P_p^\perp [\nabla \cdot u_h], P_p^\perp [\nabla \cdot v_h] \right) \\ & + \alpha_\sigma \left( P_\sigma^\perp \left[ (1-\beta) \nabla^s u_h - \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla \sigma_h - g(\hat{u}_h, \hat{\sigma}_h)) \right], P_\sigma^\perp [\nabla^s v_h] \right) = \langle f, v_h \rangle, \end{aligned} \quad (5.1)$$

$$(\nabla \cdot u_h, q_h) + \alpha_u \left( P_u^\perp [\nabla p_h], P_u^\perp [\nabla q_h] \right) = 0, \quad (5.2)$$

$$\begin{aligned} & \left( \frac{1}{2\mu} \sigma_h - (1-\beta) \nabla^s u_h, \tau_h \right) + \frac{\lambda}{2\mu} (\partial_t \sigma_h, \tau_h) + \frac{\lambda}{2\mu} \tilde{c}(\hat{u}_h, \sigma_h, \tau_h) \\ & - \frac{\lambda}{2\mu} (g(\hat{u}_h, \hat{\sigma}_h), \tau_h) + (1-\beta) \alpha_u \left( P_u^\perp [\nabla \cdot \sigma_h], P_u^\perp [\nabla \cdot \tau_h] \right) \\ & + \alpha_\sigma \left( P_\sigma^\perp \left[ -(1-\beta) \nabla^s u_h + \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla \sigma_h - g(\hat{u}_h, \hat{\sigma}_h)) \right], \right. \\ & \left. P_\sigma^\perp \left[ \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla \tau_h + g^*(\hat{u}_h, \tau_h)) \right] \right) = 0, \end{aligned} \quad (5.3)$$

for all  $V_h = (v_h, q_h, \tau_h) \in \mathcal{X}_h$ . The initial conditions are set as appropriate projections of  $u_0$  and  $\sigma_0$ . The stabilisation parameters are computed using  $\hat{u}_h$  (see (4.6)-(4.8)).

## 5.2 Existence and uniqueness of the semi-discrete solution

The following existence and uniqueness analysis of the discrete solution was motivated by the procedure followed in Burman & Fernández (2007) for the two-field Navier-Stokes problem.

To prove existence and uniqueness of the discrete linearised problem (5.1)-(5.3), we shall make use of the following pressure and velocity subspaces:

$$\begin{aligned} \mathcal{Q}_h^* &= \left\{ q_h \in \mathcal{Q}_h \mid \left( P_{u,0}^\perp [\nabla q_h], P_{u,0}^\perp [\nabla q_h] \right) = 0 \right\}, \\ \mathcal{Y}_h^{\text{div}} &= \{ v_h \in \mathcal{Y}_h \mid (q_h, \nabla \cdot v_h) = 0, \forall q_h \in \mathcal{Q}_h^* \}. \end{aligned}$$

In addition,  $\mathcal{Q}_h \setminus \mathcal{Q}_h^*$  will stand for the supplementary of  $\mathcal{Q}_h^*$  in  $\mathcal{Q}_h$ , i.e.,  $\mathcal{Q}_h = (\mathcal{Q}_h \setminus \mathcal{Q}_h^*) \oplus \mathcal{Q}_h^*$ .

To ensure that  $\mathcal{Y}_h^{\text{div}}$  is not trivial, we use the following lemma:

LEMMA 5.1 *There exists a constant  $\gamma > 0$ , independent of  $h$ , such that*

$$\inf_{q_h \in \mathcal{Q}_h^*} \sup_{v_h \in \mathcal{Y}_h} \frac{(q_h, \nabla \cdot v_h)}{\|v_h\|_1 \|q_h\|} \geq \gamma.$$

*Proof.* Let  $q_h \in \mathcal{Q}_h^*$ . From inf-sup theory (see for example Girault & Raviart (1986)), there exists  $v_q \in (H_0^1(\Omega))^d$  such that

$$\nabla \cdot v_q = q_h, \quad \|v_q\|_1 \lesssim \|q_h\|.$$

Integrating by parts, we have

$$\|q_h\|^2 = (q_h, \nabla \cdot v_q)$$

$$\begin{aligned}
&= -(\nabla q_h, v_q - P_{u,0}[v_q]) + (q_h, \nabla \cdot P_{u,0}[v_q]) \\
&= (q_h, \nabla \cdot P_{u,0}[v_q]),
\end{aligned}$$

since, as  $q_h \in Q_h^*$ , then  $\nabla q_h \in \mathcal{Y}_h$ , and  $v_q - P_{u,0}[v_q]$  belongs to the orthogonal to this space. In addition, using the quasi-uniformity of the mesh and the Poincaré-Friedrics inequality we have

$$\|P_{u,0}[v_q]\|_1^2 \lesssim \|\nabla v_q\|^2 \lesssim \|q_h\|^2,$$

which completes the proof.  $\square$

**THEOREM 5.1 (Existence-Uniqueness)** *The semi discrete problem (5.1)-(5.3) has a unique solution.*

*Proof.* Problem (5.1)-(5.3), satisfying the initial conditions, can be written in operator form as

$$M_u \partial_t u_h + K_u(\hat{u}_h) u_h + G p_h - D_\sigma \sigma_h = M_u f \quad \text{in } \mathcal{Y}_h, \quad (5.4)$$

$$D u_h = S_{1,p}^\perp p_h \quad \text{in } Q_h, \quad (5.5)$$

$$M_\sigma \partial_t \sigma_h + K_\sigma(\hat{u}_h, \hat{\sigma}_h) \sigma_h - S u_h = 0 \quad \text{in } Y_h. \quad (5.6)$$

These are equations posed in terms of linear forms defined on the spaces specified in each equation. The components these forms when applied to  $v_h \in \mathcal{Y}_h$ ,  $q_h \in Q_h$  and  $\tau_h \in Y_h$  are given by

$$\begin{aligned}
M_u f(v_h) &= \langle f, v_h \rangle, \\
(K_u(\hat{u}_h) u_h)(v_h) &= \rho \tilde{c}(\hat{u}_h, u_h, v_h) + 2\beta \mu (\nabla^s u_h \nabla^s v_h) + \alpha_u \left( P_u^\perp [\rho \hat{u}_h \cdot \nabla u_h], P_u^\perp [\rho \hat{u}_h \cdot \nabla v_h] \right) \\
&\quad + \alpha_p \left( P_p^\perp [\nabla \cdot u_h], P_p^\perp [\nabla \cdot v_h] \right) \\
&\quad + (1 - \beta) \alpha_\sigma \left( P_\sigma^\perp \left[ (1 - \beta) \nabla^s u_h - \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla \sigma_h - g(\hat{u}_h, \sigma_h)) \right], P_\sigma^\perp [\nabla^s v_h] \right), \\
G p_h(v_h) &= - (p_h, \nabla \cdot v_h), \\
D_\sigma \sigma_h(v_h) &= (\sigma_h, \nabla^s v_h), \\
D u_h(q_h) &= (\nabla \cdot u_h, q_h), \\
S_{1,p}^\perp p_h(q_h) &= - \alpha_u \left( P_u^\perp [\nabla q_h], P_u^\perp [\nabla q_h] \right), \\
M_\sigma \partial_t \sigma_h(\tau_h) &= \frac{\lambda}{2\mu} (\partial_t \sigma_h, \tau_h), \\
(K_\sigma(\hat{u}_h, \hat{\sigma}_h) \sigma_h)(\tau_h) &= \frac{1}{2\mu} (\sigma_h, \tau_h) + \frac{\lambda}{2\mu} \tilde{c}(\hat{u}_h, \sigma_h, \tau_h) + (1 - \beta) \alpha_u \left( P_u^\perp [\nabla \cdot \sigma_h], P_u^\perp [\nabla \cdot \tau_h] \right) \\
&\quad + \alpha_\sigma \left( P_\sigma^\perp \left[ -(1 - \beta) \nabla^s u_h + \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla \sigma_h - g(\hat{u}_h, \hat{\sigma}_h)) \right], \right. \\
&\quad \left. P_\sigma^\perp \left[ \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla \tau_h + g^*(\hat{u}_h, \tau_h)) \right] \right), \\
S u_h(\tau_h) &= - (1 - \beta) (\nabla^s u_h, \tau_h).
\end{aligned}$$

We also introduce the operator  $D^1 : \mathcal{Y}_h \longrightarrow (Q_h^*)'$ , defined by

$$D^1 v_h = (D v_h)_{Q_h^*}, \quad \forall v_h \in \mathcal{Y}_h,$$

where the subscript stands for the restriction to  $Q_h^*$ . From Lemma 1, it follows that  $D^1$  is surjective and  $(D^1)^T$  is injective, and therefore,  $\mathcal{Y}_h^{\text{div}} := \ker(D^1) \neq \{\mathbf{0}\}$ .

Let us consider the following reduced formulation, derived from (5.1)-(5.3) with  $V_h \in \mathcal{X}_h^* = \mathcal{Y}_h^{\text{div}} \times (Q_h \setminus Q_h^*) \times \mathcal{Y}_h$ : find  $U_h = (u_h, \tilde{p}_h, \sigma_h) : ]0, T[ \rightarrow \mathcal{X}_h^*$  such that

$$M_u \partial_t u_h + K_u(\hat{u}_h) u_h + G \tilde{p}_h - D_\sigma \sigma_h = M_u f \quad \text{in } \mathcal{Y}_h^{\text{div}}, \quad (5.7)$$

$$D u_h = S_{1,p}^\perp \tilde{p}_h \quad \text{in } (Q_h \setminus Q_h^*), \quad (5.8)$$

$$M_\sigma \partial_t \sigma_h + K_\sigma(\hat{u}_h, \hat{\sigma}_h) \sigma_h - S u_h = 0 \quad \text{in } \mathcal{Y}_h. \quad (5.9)$$

Since, by construction,  $Q_h^* = \text{Ker}(S_{1,p}^\perp)$ , we conclude that  $S_{1,p}^\perp$  is invertible in  $Q_h \setminus Q_h^*$ , and therefore, from (5.8) we obtain

$$\tilde{p}_h = \left( S_{1,p}^\perp \right)_{Q_h \setminus Q_h^*}^{-1} D u_h.$$

By plugging this expression into (5.7), we obtain the following equivalent problem:

$$M_u \partial_t u_h + K_u(\hat{u}_h) u_h + G \left( S_{1,p}^\perp \right)_{Q_h \setminus Q_h^*}^{-1} D u_h - D_\sigma \sigma_h = M_u f \quad \text{in } \mathcal{Y}_h^{\text{div}}, \quad (5.10)$$

$$M_\sigma \partial_t \sigma_h + K_\sigma(\hat{u}_h, \hat{\sigma}_h) \sigma_h - S u_h = 0 \quad \text{in } \mathcal{Y}_h, \quad (5.11)$$

which is a standard Cauchy problem for  $u_h$  and  $\sigma_h$ . Existence and uniqueness for  $u_h$  and  $\sigma_h$  follows by the Lipschitz continuity of  $K_u(\hat{u}_h)$  and  $K_\sigma(\hat{u}_h, \hat{\sigma}_h)$ . We may then recover  $\tilde{p}_h$  uniquely from (5.8). Therefore, the reduced problem (5.7)-(5.9) has a unique solution. On the other hand, from (5.7) it follows that

$$M_u \partial_t u_h + K_u(\hat{u}_h) u_h + G \tilde{p}_h - D_\sigma \sigma_h - M_u f \in (\text{Ker}(D^1))^0,$$

with  $(\text{Ker}(D^1))^0$  standing for the polar set of  $\text{Ker}(D^1)$ . From Lemma 1, it follows that  $D^1$  is an isomorphism from  $Q_h^*$  onto  $(\text{Ker}(D^1))^0$ . Thus, there exists a unique  $p^1 \in Q_h^*$  such that

$$M_u \partial_t u_h + K_u(\hat{u}_h) u_h + G \tilde{p}_h - D_\sigma \sigma_h - M_u f = G p^1 \quad \text{in } \mathcal{Y}_h. \quad (5.12)$$

Therefore, from (5.12) and the reduced problem (5.7)-(5.9), it follows that the discrete problem (5.1)-(5.3) has a unique solution, given by  $(u_h, \tilde{p}_h - p^1, \sigma_h)$ .  $\square$

### 5.3 Stability of the linearised semi-discrete problem

We will use the following working norm in the subsequent analysis:

$$\begin{aligned} \|V_h\|_W^2 &= 2\beta\mu(1-\beta) \|\nabla^s v_h\|^2 + \frac{1}{2\mu} \|\tau_h\|^2 + (1-\beta)\alpha_u \left\| P_u^\perp [\rho \hat{u}_h \cdot \nabla v_h] \right\|^2 \\ &\quad + (1-\beta)\alpha_u \|\rho \partial_t v_h + \rho \hat{u}_h \cdot \nabla v_h + \nabla q_h - \nabla \cdot \tau_h\|^2 \\ &\quad + (1-\beta)\alpha_p \|\nabla \cdot v_h\|^2 + (1-\beta)\alpha_u \left\| P_u^\perp [\nabla q_h] \right\|^2 + (1-\beta)\alpha_u \left\| P_u^\perp [\nabla \cdot \tau_h] \right\|^2 \\ &\quad + \alpha_\sigma \left\| \frac{\lambda}{2\mu} \partial_t \tau_h - (1-\beta) \nabla^s v_h + \frac{\lambda}{2\mu} \hat{u}_h \cdot \nabla \tau_h \right\|^2. \end{aligned} \quad (5.13)$$

The term multiplied by  $\alpha_p$  is not strictly necessary, since it is already contained in  $\|\nabla^s v_h\|$ , but sometimes could reinforce stability. We will keep it for generality, to see the effect of the stabilising term associated to the pressure.

From the definition of  $\|\cdot\|_W$  it is observed that we have some control on the convective terms of the momentum equation and of the constitutive equation. In view of the expression of the stabilisation parameters, this control remains meaningful in the convection dominated limit for the momentum equation. This property will no longer be valid in the nonlinear case, since, as it is standard in the analysis of nonlinear problems involving the Navier-Stokes equation, the results will be proved in the diffusion dominated regime.

The next result states the stability of the proposed semi-discrete formulation, defined in (5.1)-(5.3).

**THEOREM 5.2 (Stability)** *Let  $(u_h, p_h, \sigma_h)$  be the solution of (5.1)-(5.3). Then, the following stability holds, for almost all  $t \in [0, T]$ :*

$$\begin{aligned} & (1-\beta) \frac{\rho}{2} \|u_h(t)\|^2 + \frac{\lambda}{4\mu} \|\sigma_h(t)\|^2 + \int_0^t \|(u_h, p_h, \sigma_h)\|_W^2 dt \\ & \lesssim \frac{c_K^2}{2\mu} \int_0^t \|f\|_{H^{-1}}^2 dt + \frac{\lambda^2}{2\mu} \int_0^t \|g(\hat{u}_h, \hat{\sigma}_h)\|^2 dt + (1-\beta) \frac{\rho}{2} \|u_0\|^2 + \frac{\lambda}{4\mu} \|\sigma_0\|^2. \end{aligned} \quad (5.14)$$

*Proof.* In this proof  $\varepsilon_1, \varepsilon_2, \dots$  are positive constants used in the application of Young's inequalities. The values will be chosen at the end of the proof.

Taking  $(v_h, q_h, \tau_h) = U_{h1} = ((1-\beta)u_h, (1-\beta)p_h, \sigma_h)$  in (5.1)-(5.3), adding up the resulting equations and using Cauchy-Schwarz's and Young's inequalities we arrive at

$$\begin{aligned} & (1-\beta) \frac{\rho}{2} \frac{d}{dt} \|u_h\|^2 + 2\mu\beta(1-\beta) \|\nabla^s u_h\|^2 + \frac{\lambda}{4\mu} \frac{d}{dt} \|\sigma_h\|^2 \\ & + (1-\beta)\alpha_p \left\| P_p^\perp [\nabla \cdot u_h] \right\|^2 + (1-\beta)\alpha_u \left\| P_u^\perp [\nabla \cdot \sigma_h] \right\|^2 \\ & + \frac{1}{2\mu} \left( 1 - \frac{\varepsilon_1}{2} - 4 \frac{\alpha_\sigma}{2\mu} \lambda^2 \|\nabla \hat{u}_h\|_\infty^2 \left( \frac{1}{2\varepsilon_2} + \frac{1}{2\varepsilon_4} \right) \right) \|\sigma_h\|^2 \\ & + (1-\beta)\alpha_u \left\| P_u^\perp [\rho \hat{u}_h \cdot \nabla u_h] \right\|^2 + (1-\beta)\alpha_u \left\| P_u^\perp [\nabla p_h] \right\|^2 \\ & + \alpha_\sigma \left( 1 - \frac{\varepsilon_2}{2} - \frac{\varepsilon_3}{2} \right) \left\| P_\sigma^\perp \left[ -(1-\beta)\nabla^s u_h + \frac{\lambda}{2\mu} (\partial_t \sigma_h + \hat{u}_h \cdot \nabla \sigma_h) \right] \right\|^2 \\ & \leq (1-\beta) \langle f, u_h \rangle + \frac{\lambda^2}{4\mu} \left[ \frac{1}{\varepsilon_1} \|g(\hat{u}_h, \hat{\sigma}_h)\|^2 + \frac{\alpha_\sigma}{\mu} \left( \frac{1}{2\varepsilon_3} + \frac{\varepsilon_4}{2} \right) \left\| P_\sigma^\perp [g(\hat{u}_h, \hat{\sigma}_h)] \right\|^2 \right]. \end{aligned} \quad (5.15)$$

If we compare the bounded terms of expression (5.15) with the terms of the working norm (5.13), we can see that the missing terms are all of them associated to the finite element space. The key point is that this missing control comes from the Galerkin part of the multilinear form  $B_{\text{stab}}$  in Eq. (4.2).

Let us take  $V_{h1} = (v_h, q_h, \tau_h) = \alpha_u ((1-\beta)v_1, 0, 0)$  with

$$v_1 \equiv P_{u,0} [\rho \partial_t u_h + \rho \hat{u}_h \cdot \nabla u_h + \nabla p_h - \nabla \cdot \sigma_h].$$

Then, we can proceed in a similar way as in the  $U_{h1}$  case. Taking  $v_1$  as test function, integrating by parts the terms arising from the divergence of the total stress and the gradient of the pressure, using the fact

that  $\hat{u}_h = 0$  on  $\partial\Omega$ , and applying Cauchy-Schwarz's and Young's inequalities and inverse inequalities, we obtain the following result

$$\begin{aligned}
& (1-\beta)\alpha_u \left( 1 - \alpha_u c_{\text{inv}}^2 \left[ \frac{\alpha_p \varepsilon_6}{h^2} \frac{\varepsilon_7}{2} + \frac{\rho \|\hat{u}_h\|_\infty \varepsilon_7}{h} \frac{\varepsilon_7}{2} + \frac{\alpha_\sigma}{h^2} \left( \frac{\varepsilon_8}{2} + \frac{\varepsilon_9}{2} \right) \right] \right. \\
& \quad \left. - \beta \alpha_u \frac{2\mu}{h^2} c_{\text{inv}}^2 \frac{\varepsilon_5}{2} - \alpha_u \frac{d}{4\varepsilon_{10}} \frac{c_K^2}{2\mu} \rho^2 \|\nabla \hat{u}_h\|_\infty^2 \right) \|v_1\|^2 \\
& \quad - 2\mu(1-\beta) \left( \beta \frac{1}{2\varepsilon_5} + \frac{\varepsilon_{10}}{2} \right) \|\nabla^s u_h\|^2 - (1-\beta)\alpha_p \frac{1}{2\varepsilon_6} \left\| P_p^\perp [\nabla \cdot u_h] \right\|^2 \\
& \quad - (1-\beta)\alpha_u^2 \frac{\rho \|\hat{u}_h\|_\infty}{h} \frac{1}{2\varepsilon_7} \left\| P_u^\perp [\rho \hat{u}_h \cdot \nabla u_h] \right\|^2 \\
& \quad - (1-\beta)\alpha_\sigma \frac{1}{2\varepsilon_8} \left\| P_\sigma^\perp \left[ \frac{\lambda}{2\mu} \partial_t \sigma_h - (1-\beta)\nabla^s u_h + \frac{\lambda}{2\mu} \hat{u}_h \cdot \nabla \sigma_h \right] \right\|^2 \\
& \leq (1-\beta)\alpha_u \langle f, v_1 \rangle + \frac{(1-\beta)\lambda^2 \alpha_\sigma}{2\varepsilon_9} \frac{\alpha_\sigma}{2\mu} \left\| P_\sigma^\perp [g(\hat{u}_h, \hat{\sigma}_h)] \right\|^2. \tag{5.16}
\end{aligned}$$

To obtain the control of  $P_p[\nabla \cdot u_h]$ , we proceed taking  $V_{h2} = (1-\beta)\alpha_p(0, q_2, 0)$  with  $q_2 \equiv P_p[\nabla \cdot u_h]$ :

$$\begin{aligned}
(1-\beta)\alpha_p \left( (\nabla \cdot u_h, q_2) + \alpha_u \left( P_u^\perp [\nabla p_h], \nabla q_2 \right) \right) & \geq (1-\beta)\alpha_p \left( 1 - c_{\text{inv}}^2 \alpha_u \frac{\alpha_p \varepsilon_{11}}{h^2} \frac{\varepsilon_{11}}{2} \right) \left\| P_p[\nabla \cdot u_h] \right\|^2 \\
& \quad - (1-\beta)\alpha_u \frac{1}{2\varepsilon_{11}} \left\| P_u^\perp [\nabla p_h] \right\|^2. \tag{5.17}
\end{aligned}$$

Finally, taking:  $V_{h3} = \alpha_\sigma(0, 0, \sigma_3)$  with  $\sigma_3 \equiv P_\sigma \left[ \frac{\lambda}{2\mu} \partial_t \sigma_h - (1-\beta)\nabla^s u_h + \frac{\lambda}{2\mu} \hat{u}_h \cdot \nabla \sigma_h \right]$ , and proceeding as before, we obtain

$$\begin{aligned}
& - \frac{1}{2\mu} \left( \frac{1}{2\varepsilon_{12}} + \frac{1}{2} \frac{1}{2\varepsilon_{17}} \right) \|\sigma_h\|^2 - \frac{(1-\beta)}{2\varepsilon_{14}} \alpha_u \left\| P_u^\perp [\nabla \cdot \sigma_h] \right\|^2 \\
& + \alpha_\sigma \left( 1 - \frac{\alpha_\sigma \varepsilon_{12}}{2\mu} \frac{\varepsilon_{12}}{2} - \frac{\varepsilon_{13}}{2} - \frac{\varepsilon_{17}}{4} \frac{\alpha_\sigma}{2\mu} d(\lambda \|\nabla \hat{u}_h\|_\infty)^2 - c_{\text{inv}}^2 (1-\beta)\alpha_u \frac{\alpha_\sigma \varepsilon_{14}}{h^2} \frac{\varepsilon_{14}}{2} \right. \\
& \quad \left. - c_{\text{inv}}^2 2\alpha_\sigma^2 \left[ \left( \frac{\lambda \|\hat{u}_h\|_\infty}{2\mu h} \right)^2 + 4 \left( \frac{\lambda \|\nabla \hat{u}_h\|_\infty}{2\mu} \right)^2 \right] \left( \frac{1}{2\varepsilon_{15}} + \frac{1}{2\varepsilon_{16}} \right) \right) \|\sigma_3\|^2 \\
& - \alpha_\sigma \frac{\varepsilon_{15}}{2} \left\| P_\sigma^\perp \left[ \frac{\lambda}{2\mu} \partial_t \sigma_h - (1-\beta)\nabla^s u_h + \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla \sigma_h) \right] \right\|^2 \\
& \leq \frac{\lambda^2 \alpha_\sigma}{4\mu} \frac{\alpha_\sigma}{\mu} \left( \frac{1}{2\varepsilon_{13}} \|g(\hat{u}_h, \hat{\sigma}_h)\|^2 + \frac{\varepsilon_{16}}{2} \left\| P_\sigma^\perp [g(\hat{u}_h, \hat{\sigma}_h)] \right\|^2 \right). \tag{5.18}
\end{aligned}$$

Let  $V_h^* = U_{h1} + \theta_1 V_{h1} + \theta_2 V_{h2} + \theta_3 V_{h3}$ , with  $V_{hi}$ ,  $i = 1, \dots, 3$  introduced above. Adding (5.16)-(5.18) multiplied by  $\theta_i$ ,  $i = 1, \dots, 3$ , and adding also (5.15), we arrive at an expression of the form

$$LHS(V_h^*) \leq RHS(V_h^*).$$

For the RHS, applying Young's inequalities and the inverse inequality, we obtain

$$RHS(V_h^*) \leq (1-\beta) \left( \frac{1}{2\mu} \left( \frac{1}{2\varepsilon_{17}} + \theta_1 \frac{1}{2\varepsilon_{18}} \right) c_\Omega^2 \|f\|_{H^{-1}}^2 \right)$$

$$\begin{aligned}
& + 2\mu \frac{\varepsilon_{17}}{2} \|\nabla^s u_h\|^2 + \theta_1 \alpha_u \left( \alpha_u \frac{2\mu}{h^2} \right) c_{\text{inv}}^2 \frac{\varepsilon_{18}}{2} \|v_1\|^2 \\
& + \frac{\lambda^2}{2\mu} \left( \frac{1}{2\varepsilon_1} + \theta_3 \frac{\alpha_\sigma}{2\mu} + \frac{\alpha_\sigma}{2\mu} \left( \frac{1}{2\varepsilon_3} + \frac{\varepsilon_4}{2} + \theta_1 \frac{(1-\beta)}{2\varepsilon_9} + \theta_3 \frac{\varepsilon_{16}}{2} \right) \right) \|g(\hat{u}_h, \hat{\sigma}_h)\|^2. \quad (5.19)
\end{aligned}$$

For the left-hand-side (LHS), integrating inequalities (5.15),(5.16),(5.17), (5.18) and (5.19) from 0 to  $t$ , we obtain

$$\begin{aligned}
& (1-\beta) \frac{\rho}{2} \|u_h\|^2(t) + \frac{\lambda}{4\mu} \|\sigma_h\|^2(t) + 2\mu(1-\beta)\beta C_1 \int_0^t \|\nabla^s u_h\|^2 dt \\
& + \frac{1}{2\mu} C_2 \int_0^t \|\sigma_h\|^2 dt + (1-\beta) C_3 \alpha_u \int_0^t \left\| P_u^\perp [\rho \hat{u}_h \cdot \nabla u_h] \right\|^2 dt \\
& + (1-\beta) C_4 \alpha_p \int_0^t \left\| P_p^\perp [\nabla \cdot u_h] \right\|^2 dt + (1-\beta) C_5 \alpha_u \int_0^t \left\| P_u^\perp [\nabla \cdot \sigma_h] \right\|^2 dt \\
& + (1-\beta) C_6 \alpha_u \int_0^t \left\| P_u^\perp [\nabla p_h] \right\|^2 dt + C_7 \alpha_\sigma \int_0^t \left\| P_\sigma^\perp \left[ -(1-\beta) \nabla^s u_h + \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla \sigma_h) \right] \right\|^2 dt \\
& + (1-\beta) C_8 \alpha_u \int_0^t \left\| P_{u,0} [\rho \partial_t u_h + \rho \hat{u}_h \cdot \nabla u_h + \nabla p_h - \nabla \cdot \sigma_h] \right\|^2 dt \\
& + (1-\beta) C_9 \alpha_p \int_0^t \left\| P_p [\nabla \cdot u_h] \right\|^2 dt \\
& + C_{10} \alpha_\sigma \int_0^t \left\| P_\sigma \left[ \frac{\lambda}{2\mu} \partial_t \sigma_h - (1-\beta) \nabla^s u_h + \frac{\lambda}{2\mu} \hat{u}_h \cdot \nabla \sigma_h \right] \right\|^2 dt \\
& \leq (1-\beta) \frac{c_\Omega^2}{2\mu} C_{11} \int_0^t \|f\|_{H^{-1}}^2 dt + \frac{\lambda^2}{2\mu} C_{12} \int_0^t \|g(\hat{u}_h, \hat{\sigma}_h)\|^2 dt + (1-\beta) \frac{\rho}{2} \|u_h(0)\|^2 + \frac{\lambda}{4\mu} \|\sigma_h(0)\|^2, \quad (5.20)
\end{aligned}$$

where  $C_i$ ,  $i = 1, \dots, 12$ , can be easily identified. The result then follows by choosing  $\varepsilon_1, \dots, \varepsilon_{18}$  and  $\theta_1, \dots, \theta_3$ , in such a way that  $C_i > 0$  for all  $i$ , which is possible by choosing some of the constants and the algorithmic stabilisation parameters sufficiently small. The missing control on  $\rho \partial_t u_h + \rho \hat{u}_h \cdot \nabla u_h + \nabla p_h - \nabla \cdot \sigma_h$  follows from (4.9).  $\square$

## 6. Analysis of the nonlinear problem

In this section we show that under suitable conditions, a solution to the discretized system exists. Using the same procedure proposed by Ervin & Miles (2003), the proof can be subdivided in the following four steps:

1. Define an iterative map in such a way that a fixed point of the map is a solution to the original problem.
2. Show that the map is well defined and bounded on bounded sets.
3. Show that there exists an invariant ball of the map.
4. Apply Schauder's fixed point theorem to conclude there exists a discrete solution in this ball.

The results to be obtained in this section yield existence of a semi-discrete solution, as well as stability and convergence. Due to the hypotheses needed in the proof of the results (most of which are already present in the analysis of the Navier-Stokes equation), the norm in which the results are shown is weaker than the norm used in the linearised problem. In essence, we will have  $L^\infty(0, T)$ -control for both the  $L^2(\Omega)$ -norm of velocity and stresses and  $L^2(0, T)$ -control for the  $H^1(\Omega)$ -norm of velocity. The pressure, on the other hand, is controlled only in a norm involving the stabilisation term, and not the natural  $L^2(\Omega)$ -norm.

The precise assumptions required on the continuous solution are:

**Assumption 1.** *System (3.10) has a solution  $(u, p, \sigma)$  continuous in time and satisfying*

$$\begin{aligned} \sup_{0 \leq t \leq T} \|u\|_\infty &\leq D_1, & \sup_{0 \leq t \leq T} \|\nabla u\|_\infty &\leq D_2, & \sup_{0 \leq t \leq T} \|u\|_{k+1} &\leq D_3, \\ \sup_{0 \leq t \leq T} \|\sigma\|_\infty &\leq D_4, & \sup_{0 \leq t \leq T} \|\nabla \sigma\|_\infty &\leq D_5, & \sup_{0 \leq t \leq T} \|\sigma\|_{k+1} &\leq D_6, \\ \sup_{0 \leq t \leq T} \|p\|_k &\leq D_7, & \sup_{0 \leq t \leq T} \|\partial_t u\|_k &\leq D_8, & \sup_{0 \leq t \leq T} \|\partial_t \sigma\|_k &\leq D_9, \end{aligned} \quad (6.1)$$

for certain positive constants  $D_i$   $i = 1, \dots, 9$  which are supposed to be small enough.

For the time-discrete problem, if  $\delta t$  is the time step size, one usually needs a condition of the form  $\delta t \geq C\alpha_u$  for a positive constant  $C$ , which is encountered in most stabilised finite element methods; see Badia & Codina (2009); Codina *et al.* (2007) and references therein for a description of the problem and a way to avoid this restriction, which we shall not consider in this work. In the time continuous case, the boundedness in time of  $\|p\|_k$  and the assumption that  $T$  is large enough allows us to prove convergence, as we show next. We do not pretend however to consider the long-term behaviour of the solution, which would require the modification of the stabilised formulation and the analysis presented in Badia *et al.* (2010).

In order to write all estimates in dimensionless form, let  $L_d$  be a characteristic length of the problem and  $T_d$  a characteristic time scale. These parameters may explode with the viscosity, and therefore the estimates are not valid for high Reynolds numbers. The main result on existence and convergence reads as follows:

**THEOREM 6.1 (Convergence)** *Let  $k$  be the interpolation order, assumed to be the same for all variables, with  $k \geq d/2$ . Suppose also that Assumptions 1 holds, that  $T$  is sufficiently large and that the  $L^2(0, T; (H^{-1}(\Omega))^d)$ -norm of  $f$  is bounded. Then, if the viscosity is sufficiently large, there exists a solution to (5.1)-(5.3) satisfying*

$$\begin{aligned} \sup_{0 \leq t \leq T} \|u - u_h\|^2 + \frac{1}{T_d} \int_0^T (L_d \|\nabla(u - u_h)\|)^2 dt &\leq u_*^2 h^{2k}, \\ \sup_{0 \leq t \leq T} \|\sigma - \sigma_h\|^2 &\leq \sigma_*^2 h^{2k}, \\ \int_0^T \alpha_u \|\nabla(p - p_h)\|^2 dt &\leq p_*^2 h^{2k}, \end{aligned} \quad (6.2)$$

where  $u_*$ ,  $p_*$  and  $\sigma_*$  are appropriate dimensional factors that render the estimates dimensionally consistent.

*Proof.*

**Step 1.** *The iterative map.* A mapping  $\delta : L^2(0, T; \mathcal{V}_h) \times L^2(0, T; Q_h) \times L^\infty(0, T; \Upsilon_h) \rightarrow L^2(0, T; \mathcal{V}_h) \times$



$L^2(0, T; Q_h) \times L^\infty(0, T; Y_h)$  is defined via  $(u_h, p_h, \sigma_h) = \delta(\hat{u}_h, \hat{p}_h, \hat{\sigma}_h)$ , where  $U_h = (u_h, p_h, \sigma_h)$  satisfies (5.1)-(5.3), for all  $V_h = (v_h, q_h, \tau_h) \in \mathcal{X}_h$ . Thus, given an initial guess for the three unknowns  $\hat{U}_h := (\hat{u}_h, \hat{p}_h, \hat{\sigma}_h)$ , solving the above system for  $(u_h, p_h, \sigma_h)$  gives a new approximation to the solution. Also, it is clear that the fixed point is a solution to the approximating system (5.1)-(5.3), i.e.  $\delta(u_h, p_h, \sigma_h) = (u_h, p_h, \sigma_h)$  implies that  $(u_h, p_h, \sigma_h)$  is a solution to (4.1).

**Step 2.** *The mapping  $\delta$  is well defined and bounded on bounded sets.*

The existence and uniqueness of the discrete solution was proved in subsection 5.2 for a linearised problem, that can be associated to the solution of the fixed point problem.

The stability result proved in subsection 5.3 ensures that the linearised problem, that can be viewed as a fixed point iteration of the nonlinear case, is stable and bounded under suitable regularity assumptions. Note that this step is crucial in the definition of the fixed point mapping and can be used to establish that the mapping  $\delta$  is bounded on bounded sets.

**Step 3.** *Existence of an invariant ball.* We begin defining an invariant ball. Let  $R = h^k$ , and for  $V = (v, q, \tau)$  let us define the norm

$$\|V\|_B^2 := \rho \sup_{0 \leq t \leq T} \|v\|^2 + \frac{\rho}{T_d} \int_0^T (L_d \|\nabla v\|)^2 dt + \frac{\lambda}{\mu} \sup_{0 \leq t \leq T} \|\tau\|^2 + \alpha_u \int_0^T \|\nabla q\|^2 dt. \quad (6.3)$$

As we shall see, our result could be proved in a finer norm, but the additional terms that we could include in  $\|\cdot\|_B$  (see below) do not provide significant additional control for large viscosities. Let us define now the ball  $\mathcal{B}_h$  as

$$\mathcal{B}_h = \left\{ V_h = (v_h, q_h, \tau_h) : ]0, T[ \rightarrow \mathcal{X}_h \text{ such that } \|V_h - U\|_B \leq U_* R \right\}, \quad (6.4)$$

where  $U_*^2 = \rho u_*^2 + \frac{\lambda}{\mu} \sigma_*^2 + p_*^2$  and  $u_*$ ,  $p_*$  and  $\sigma_*$  are constructed along the proof. In the definition (6.4),  $U = (u, p, \sigma)$  is the solution of (3.10).

Let us pick now  $\hat{U}_h := (\hat{u}_h, \hat{p}_h, \hat{\sigma}_h) \in \mathcal{B}_h$ , arbitrary, and let  $U_h = (u_h, p_h, \sigma_h) = \delta(\hat{u}_h, \hat{p}_h, \hat{\sigma}_h)$ ; it satisfies (5.1)-(5.3). Then, it is readily checked that

$$\begin{aligned} & \rho (\partial_t (u - u_h), v_h) + \rho (\tilde{c}(u, u, v_h) - \tilde{c}(\hat{u}_h, u_h, v_h)) \\ & + 2\beta \mu (\nabla^s (u - u_h), \nabla^s v_h) + (\sigma - \sigma_h, \nabla^s v_h) - (p - p_h, \nabla \cdot v_h) \\ & - \alpha_u \left( P_u^\perp [\rho \hat{u}_h \cdot \nabla u_h], P_u^\perp [\rho \hat{u}_h \cdot \nabla v_h] \right) - \alpha_p \left( P_p^\perp [\nabla \cdot u_h], P_p^\perp [\nabla \cdot v_h] \right) \\ & + (\nabla \cdot (u - u_h), q_h) - \alpha_u \left( P_u^\perp [\nabla p_h], P_u^\perp [\nabla q_h] \right) \\ & + \frac{1}{2\mu} (\sigma - \sigma_h, \tau_h) - (1 - \beta) (\nabla^s (u - u_h), \tau_h) + \frac{\lambda}{2\mu} (\partial_t (\sigma - \sigma_h), \tau_h) \\ & + \frac{\lambda}{2\mu} (\tilde{c}(u, \sigma, \tau_h) - \tilde{c}(\hat{u}_h, \sigma_h, \tau_h)) - \frac{\lambda}{2\mu} (g(u, \sigma), \tau_h) + \frac{\lambda}{2\mu} (g(\hat{u}_h, \hat{\sigma}_h), \tau_h) \\ & - (1 - \beta) \alpha_u \left( P_u^\perp [\nabla \cdot \sigma_h], P_u^\perp [\nabla \cdot \tau_h] \right) \\ & - \alpha_\sigma \left( P_\sigma^\perp \left[ -(1 - \beta) \nabla^s u_h + \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla \sigma_h - g(\hat{u}_h, \hat{\sigma}_h)) \right], \right. \\ & \left. P_\sigma^\perp \left[ -\nabla^s v_h + \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla \tau_h + g^*(\hat{u}_h, \tau_h)) \right] \right) = 0. \quad (6.5) \end{aligned}$$

Let us define the following approximation and interpolation errors:

$$\begin{aligned}\Lambda &= u - \mathcal{U} \text{ and } E = \mathcal{U} - u_h, \\ \Gamma &= \sigma - \Sigma \text{ and } F = \Sigma - \sigma_h, \\ \Pi &= p - \mathcal{P} \text{ and } G = \mathcal{P} - p_h,\end{aligned}$$

where  $\mathcal{U} = P_{u,0}[u]$ ,  $\Sigma = P_\sigma[\sigma]$  and  $\mathcal{P} = P_p[p]$ . We obviously have that  $e_u = u - u_h = \Lambda + E$ ,  $e_\sigma = \sigma - \sigma_h = \Gamma + F$ ,  $e_p = p - p_h = \Pi + G$ .

Let us describe the strategy to prove that  $U$  belongs to the ball  $\mathcal{B}_h$ . Let  $P[U] = (\mathcal{U}, \Sigma, \mathcal{P})$ . From (6.5) we will show that

$$\|P[U] - U_h\|_B^2 \leq \varphi_1(D) \|U - \hat{U}_h\|_B^2 + \|U - P[U]\|_I^2 \quad (6.6)$$

where  $\varphi_1(D)$  is a certain function polynomial in terms of the components of the array of constants  $D = (D_1, \dots, D_9)$  introduced in Assumption 1 and  $\|\cdot\|_I$  is a norm of what we may consider the interpolation error  $U - P[U]$ ; this norm will appear along the proof. Thanks to the properties of the interpolation, we will check that

$$\|U - P[U]\|_I^2 \leq \varphi_2(D) h^{2k}, \quad (6.7)$$

and we can already verify that

$$\|U - P[U]\|_B^2 \leq \varphi_3(D) h^{2k}.$$

Again,  $\varphi_2(D)$  and  $\varphi_3(D)$  are functions polynomial in terms of the components of  $D$ . Using the triangle inequality, (6.6)-(6.7) and the fact that  $\hat{U}_h \in \mathcal{B}_h$ , we will have that

$$\begin{aligned}\|U - U_h\|_B^2 &\leq \|P[U] - U_h\|_B^2 + \|U - P[U]\|_B^2 \\ &\leq \varphi_1(D) U_*^2 h^{2k} + \varphi_2(D) h^{2k} + \varphi_3(D) h^{2k}.\end{aligned}$$

Taking the components of array  $D$  sufficiently small, we will be able to guarantee that

$$\|U - U_h\|_B^2 \leq U_*^2 h^{2k},$$

that is to say,  $U_h \in \mathcal{B}_h$ . Therefore, the goal is to prove (6.6) and check that (6.7) holds. The constant  $U_*$ , from which we can obtain  $u_*$ ,  $p_*$  and  $\sigma_*$ , can be taken as  $U_*^2 = c(\varphi_2(D) + \varphi_3(D))$ , with  $c > 1$ , provided  $D$  is such that  $\varphi_1(D) + c^{-1} \leq 1$ .

Taking  $v_h = (1 - \beta)(E + \gamma \alpha_u P_{u,0}[\nabla G])$ , with  $\gamma > 0$ ,  $\tau_h = F$  and  $q_h = (1 - \beta)G$  in (6.5), we obtain:

$$\rho(1 - \beta) \frac{d}{dt} \|E\|^2 + \frac{\lambda}{\mu} \frac{d}{dt} \|F\|^2 + Q(t) \lesssim N(t) + S(t) + \sum_{j=1}^{23} R_j(t), \quad (6.8)$$

where

$$\begin{aligned}Q(t) &:= \beta(1 - \beta)\mu \|E\|_1^2 + \frac{1}{\mu} \|F\|^2 + (1 - \beta)\alpha_u \left\| P_u^\perp[\rho \hat{u}_h \cdot \nabla E] \right\|^2 + (1 - \beta)\alpha_p \left\| P_p^\perp[\nabla \cdot E] \right\|^2 \\ &\quad + (1 - \beta)\alpha_u \left( \left\| P_u^\perp[\nabla G] \right\|^2 + \gamma \|P_{u,0}[\nabla G]\|^2 \right) + (1 - \beta)\alpha_u \left\| P_u^\perp[\nabla \cdot F] \right\|^2\end{aligned}$$

$$\begin{aligned}
& + \alpha_\sigma \left\| P_\sigma^\perp \left[ -(1-\beta) \nabla^s E + \frac{\lambda}{2\mu} \hat{u}_h \cdot \nabla F \right] \right\|^2, \\
N(t) & := -\rho(1-\beta) (\tilde{c}(u, u, E) - \tilde{c}(\hat{u}_h, u_h, E)) - \frac{\lambda}{2\mu} (\tilde{c}(u, \sigma, F) - \tilde{c}(\hat{u}_h, \sigma_h, F)) \\
& \quad - (1-\beta) \gamma \alpha_u \rho (\tilde{c}(u, u, P_{u,0}[\nabla G]) + \tilde{c}(\hat{u}_h, u_h, P_{u,0}[\nabla G])), \\
S(t) & := -\alpha_\sigma \left( P_\sigma^\perp \left[ -(1-\beta) \nabla^s E + \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla F) \right], g^*(\hat{u}_h, F) \right),
\end{aligned}$$

and the terms  $R_j(t)$  are defined below. From (6.8), and using (4.9) for the pressure term, we have that

$$\begin{aligned}
\|P[U] - U_h\|_B^2 & \lesssim \rho(1-\beta) \sup_{0 \leq t \leq T} \|E\|^2 + \frac{\lambda}{\mu} \sup_{0 \leq t \leq T} \|F\|^2 + \int_0^T Q(t) dt \\
& \lesssim \int_0^T \left( N(t) + S(t) + \sum_{j=1}^{23} R_j(t) \right) dt. \tag{6.9}
\end{aligned}$$

The objective is to see that all these terms in the RHS can be bounded as indicated in (6.6) or absorbed by the LHS. We will not detail the positive dimensionless constants that appear in this process, in which we will make frequent use of Young's inequality; the parameter that appears when using it will be generically denoted by  $\varepsilon$  or  $\xi$ , understanding that it is small enough. We could track the different appearances of these parameters as we have done in the proof of Theorem 2, and choose them at the end; however, since we are not interested in the values of the constants, we will proceed in a more conceptual way.

We will start with the terms  $R_j(t)$  of (6.8). Using the  $L^2$ -orthogonality between  $\Lambda$  and  $E$  and between  $\Gamma$  and  $F$  and Young's inequality, we have that

$$\begin{aligned}
R_1(t) & = -(1-\beta) \rho (\partial_t \Lambda, E) = 0, \\
R_2(t) & = -\frac{\lambda}{\mu} (\partial_t \Gamma, F) = 0, \\
R_3(t) & = (1-\beta) (\Pi, \nabla \cdot E) \lesssim \mu(1-\beta) \varepsilon \|E\|_1^2 + \frac{1}{\mu} \frac{(1-\beta)}{\varepsilon} \|\Pi\|^2.
\end{aligned}$$

The term that involves the discrete error of the pressure needs a special treatment. Using (4.9) we have that

$$\begin{aligned}
R_4(t) & = -(1-\beta) (\nabla \cdot \Lambda, G) = (1-\beta) (\Lambda, \nabla G) \\
& \lesssim \alpha_u^{-1} \frac{(1-\beta)}{\varepsilon} \|\Lambda\|^2 + (1-\beta) \varepsilon \alpha_u \left( \left\| P_u^\perp [\nabla G] \right\|^2 + \|P_{u,0}[\nabla G]\|^2 \right).
\end{aligned}$$

The following terms only need Cauchy-Schwarz's and Young's inequalities:

$$\begin{aligned}
R_5(t) & = -2\beta(1-\beta) \mu (\nabla^s \Lambda, \nabla^s E) \lesssim \beta(1-\beta) \mu \varepsilon \|E\|_1^2 + \beta(1-\beta) \mu \frac{1}{\varepsilon} \|\Lambda\|_1^2, \\
R_6(t) & = -(1-\beta) (\Gamma, \nabla^s E) \lesssim \mu(1-\beta) \varepsilon \|E\|_1^2 + \frac{1}{\mu} (1-\beta) \frac{1}{\varepsilon} \|\Gamma\|^2, \\
R_7(t) & = -\frac{1}{2\mu} (\Gamma, F) = 0,
\end{aligned}$$

$$R_8(t) = (1 - \beta) (\nabla^s \Lambda, F) \lesssim \frac{1}{\mu} (1 - \beta) \varepsilon \|F\|^2 + \mu (1 - \beta) \frac{1}{\varepsilon} \|\Lambda\|_1^2.$$

Taking the parameter  $\varepsilon$  small enough, it can be readily checked that the contributions from  $R_j$  can be absorbed by  $Q(t)$  or are interpolation errors that behave as indicated in (6.7).

Let us treat now the terms of the RHS of (6.8) that come from the stabilisation. Using Cauchy-Schwarz's and Young's inequalities, we can easily control the following terms:

$$\begin{aligned} R_9(t) &= (1 - \beta) \alpha_u \left( P_u^\perp [\rho \hat{u}_h \cdot \nabla \mathcal{U}], P_u^\perp [\rho \hat{u}_h \cdot \nabla E] \right), \\ R_{10}(t) &= (1 - \beta) \alpha_p \left( P_p^\perp [\nabla \cdot \mathcal{U}], P_p^\perp [\nabla \cdot E] \right), \\ R_{11}(t) &= (1 - \beta) \alpha_u \left( P_u^\perp [\nabla \mathcal{P}], P_u^\perp [\nabla G] \right), \\ R_{12}(t) &= (1 - \beta) \alpha_u \left( P_u^\perp [\nabla \cdot \Sigma], P_u^\perp [\nabla \cdot F] \right), \\ R_{13}(t) &= \alpha_\sigma \left( P_\sigma^\perp \left[ -(1 - \beta) \nabla^s \mathcal{U} + \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla \Sigma) \right], P_\sigma^\perp \left[ -(1 - \beta) \nabla^s E + \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla F + g^*(\hat{u}_h, F)) \right] \right), \\ R_{14}(t) &= \alpha_\sigma \left( P_\sigma^\perp \left[ -\frac{\lambda}{2\mu} g(\hat{u}_h, \hat{\sigma}_h) \right], P_\sigma^\perp \left[ -(1 - \beta) \nabla^s E + \frac{\lambda}{2\mu} (\hat{u}_h \cdot \nabla F + g^*(\hat{u}_h, F)) \right] \right). \end{aligned}$$

Some of these terms need additional treatment. Let us consider first  $R_9(t)$ . When bounding it, we need to make use of the fact that

$$\begin{aligned} \alpha_u \left\| P_u^\perp [\rho \hat{u}_h \cdot \nabla \mathcal{U}] \right\|^2 &\leq \alpha_u \rho^2 \left\| P_u^\perp [(\hat{u}_h - u) \cdot \nabla (\mathcal{U} - u)] \right\|^2 + \alpha_u \rho^2 \left\| P_u^\perp [u \cdot \nabla (\mathcal{U} - u)] \right\|^2 \\ &\quad + \alpha_u \rho^2 \left\| P_u^\perp [u \cdot \nabla u] \right\|^2 + \alpha_u \rho^2 \left\| P_u^\perp [(\hat{u}_h - u) \cdot \nabla u] \right\|^2, \end{aligned} \quad (6.10)$$

where the four terms of the RHS can be shown to have structure given by (6.6) due to Assumption 1 and making use of adequate interpolation estimates.

Terms  $R_{10}(t)$  to  $R_{13}(t)$  are again bounded by terms that can be absorbed by  $Q(t)$  as well as by terms that involve the orthogonal projection of an operator applied to the projection onto the finite element space of the continuous solution. They can all be treated using the triangle inequality. For example, for the term bounding  $R_{10}(t)$  we have:

$$\left\| P_p^\perp [\nabla \cdot \mathcal{U}] \right\|^2 \leq \left\| P_p^\perp [\nabla \cdot (\mathcal{U} - u)] \right\|^2 + \left\| P_p^\perp [\nabla \cdot u] \right\|^2 \lesssim \|u\|_{k+1}^2 h^{2k}, \quad (6.11)$$

and can therefore be cast as (6.7). A similar strategy can be followed for the corresponding terms in  $R_{11}(t)$ ,  $R_{12}(t)$  and  $R_{13}(t)$ . The bound for this last term requires some more work. The first term can be treated as above, using the step just described for the term with  $\mathcal{U}$  and the same strategy as in (6.10) for  $\hat{u}_h \cdot \nabla \Sigma$ . The second term in the bound of  $R_{13}(t)$  can be absorbed by  $Q(t)$ . It only remains to treat the last term, which is particularly important because it is one of the terms responsible for the need to have  $k \geq d/2$ . It can be bounded as follows:

$$\begin{aligned} \left\| P_\sigma^\perp [g^*(\hat{u}_h, F)] \right\|^2 &\lesssim \left\| P_\sigma^\perp [g^*(\hat{u}_h - u, F)] \right\|^2 + \left\| P_\sigma^\perp [g^*(u, F)] \right\|^2 \\ &\lesssim \|\nabla(\hat{u}_h - u)\|^2 \|F\|_\infty^2 + \|\nabla u\|_\infty^2 \|F\|^2 \end{aligned}$$

$$\lesssim \left( h^{-d} \|\nabla(\hat{u}_h - u)\|^2 + \|\nabla u\|_\infty^2 \right) \|F\|^2, \quad (6.12)$$

where an inverse inequality has been used in the last step. Since  $\hat{U}_h \in \mathcal{B}_h$ ,  $\|\nabla(\hat{u}_h - u)\|^2$  is of order  $h^{2k}$ , and the condition  $k \geq d/2$  allows us to guarantee that the term in parenthesis remains bounded as  $h \rightarrow 0$ . Therefore, (6.12) (multiplied by  $\varepsilon$ ) can be absorbed by  $Q(t)$ . This concludes the analysis of  $R_{13}(t)$ .

In the bound for  $R_{14}(t)$ , the second and third terms in the RHS have already appeared when dealing with  $R_{13}(t)$ , and thus only the first term needs to be bounded. This can be done as follows:

$$\begin{aligned} \left\| P_\sigma^\perp [g(\hat{u}_h, \hat{\sigma}_h)] \right\|^2 &\lesssim \|g(\hat{u}_h - u, \hat{\sigma}_h - \sigma)\|^2 + \|g(u, \hat{\sigma}_h - \sigma)\|^2 \\ &+ \left\| P_\sigma^\perp [g(u, \sigma)] \right\|^2 + \|g(\hat{u}_h - u, \sigma)\|^2, \end{aligned} \quad (6.13)$$

where the four terms of the RHS can be bounded using (2.4) and inverse inequalities. Using the fact that  $\hat{U}_h \in \mathcal{B}_h$ ,  $k \geq d/2$  and Assumption 1, it follows that all terms contributing to bound  $R_{14}(t)$  (with the adequate factor) can be written as indicated in (6.6).

Term  $R_{15}(t)$  in (6.8) corresponds to the traction or rotational term of the Oldroyd-B constitutive model, and can be written as:

$$\begin{aligned} R_{15}(t) &= -\frac{\lambda}{2\mu} (g(u, \sigma), F) + \frac{\lambda}{2\mu} (g(\hat{u}_h, \hat{\sigma}_h), F) \\ &= -\frac{\lambda}{2\mu} (g(u, \sigma - \hat{\sigma}_h), F) + \frac{\lambda}{2\mu} (g(u - \hat{u}_h, \sigma - \hat{\sigma}_h), F) - \frac{\lambda}{2\mu} (g(u - \hat{u}_h, \sigma), F). \end{aligned} \quad (6.14)$$

The three terms in the RHS can be bounded using Cauchy-Schwarz's and Young's inequalities and the inverse inequality (2.2). When these inequalities are used in (6.14) it is seen that we again recover (6.6).

The remaining  $R_i$  terms are all multiplied by  $\gamma$ . To distinguish these terms from the others we use  $\xi$  instead of  $\varepsilon$ . The first of them can be bounded using Cauchy-Schwarz's and Young's inequalities, as well as the inverse inequality, as

$$R_{16}(t) \leq (1 - \beta) \gamma \alpha_u \|\nabla \Pi\| \|P_{u,0}[\nabla G]\| \lesssim \frac{1}{\mu} (1 - \beta) \gamma \frac{1}{\xi} \|\Pi\|^2 + (1 - \beta) \gamma \mu h^{-2} \alpha_u^2 \xi \|P_{u,0}[\nabla G]\|^2.$$

The next term requires some more elaboration. Observe first that

$$(\partial_t(u - u_h), P_{u,0}[\nabla G]) = (\partial_t u, P_{u,0}[\nabla G]) + (\partial_t \nabla \cdot u_h, G).$$

Since  $u$  is divergence free and vanishes on  $\partial\Omega$ , we have that

$$(\partial_t u, P_{u,0}[\nabla G]) = (\partial_t u, P_u[\nabla G] - \nabla G) = -(P_u^\perp[\partial_t u], P_u^\perp[\nabla G]).$$

Making use of the continuity equation (5.2) we can write

$$(\partial_t \nabla \cdot u_h, G) = -\alpha_u (\partial_t P_u^\perp[\nabla p_h], P_u^\perp[\nabla G]) = \alpha_u (\partial_t P_u^\perp[\nabla G], P_u^\perp[\nabla G]) - \alpha_u (\partial_t P_u^\perp[\nabla \mathcal{P}], P_u^\perp[\nabla G]).$$

From these two equalities, we obtain:

$$\begin{aligned} R_{17}(t) &= (1 - \beta) \gamma \alpha_u \rho (\partial_t(u - u_h), P_{u,0}[\nabla G]) \\ &= -(1 - \beta) \gamma \alpha_u \rho (P_u^\perp[\partial_t u], P_u^\perp[\nabla G]) \end{aligned}$$

$$+ (1 - \beta)\gamma\alpha_u^2\rho \frac{1}{2} \frac{d}{dt} \|P_u^\perp[\nabla G]\|^2 - (1 - \beta)\gamma\alpha_u^2\rho(\partial_t P_u^\perp[\nabla \mathcal{P}], P_u^\perp[\nabla G]).$$

After using Schwarz's and Young's inequalities, the first term in the RHS can be treated as  $R_4(t)$  (note that  $\Lambda = P_u^\perp[u]$ ), and the third term can be treated as  $R_{11}(t)$ ; therefore, they both can be cast as (6.7). It only remains to deal with the second term. Let

$$\chi_h(G(t)) := (1 - \beta)\alpha_u \|P_u^\perp[\nabla G(t)]\|^2 \geq 0.$$

After integrating in time, in (6.9) we have the terms

$$\int_0^T \chi_h(G(t)) dt + \dots \lesssim \alpha_u \rho \gamma \chi_h(G(T)) + \dots, \quad (6.15)$$

the one on the RHS coming from  $R_{17}(t)$ . Since  $\hat{U}_h \in \mathcal{B}_h$  and because of the boundedness of  $U$  described in Assumption 1, the RHS in (5.14) is bounded for all  $t$ . Since, as a consequence of the proof of Theorem 1,  $p_h$  is continuous in  $[0, \infty)$ , we have that  $\alpha_u \|P_u^\perp[\nabla p_h(t)]\|^2$  is continuous and bounded in  $t$ . Assumption 1 implies that  $\alpha_u \|P_u^\perp[\nabla p(t)]\|^2$  is also continuous and bounded in  $t$ , and therefore  $\chi_h(G(T))$  is continuous and bounded for all  $T$ . In this case, there exists  $T_0$  such that

$$\alpha_u \rho \chi_h(G(T)) \leq \int_0^T \chi_h(G(t)) dt =: \mathcal{G}(T), \quad \text{for all } T \geq T_0. \quad (6.16)$$

Let us prove this. The LHS is bounded in  $T$ , and thus the result is obvious if  $\mathcal{G}(T)$  is unbounded. Suppose now that  $\mathcal{G}(T) \nearrow M < \infty$  as  $T \rightarrow \infty$ . In this case,  $\chi_h(G(t)) \rightarrow 0^+$  as  $t \rightarrow \infty$ . Therefore, there must exist  $T_1$  such that  $\mathcal{G}(T) > M/2$  for all  $T > T_1$  and  $T_0 > T_1$  such that  $\alpha_u \rho \chi_h(G(T)) < M/2$  for all  $T > T_0$ , so that (6.16) holds.

Once (6.16) is proved, it is observed that the term in the RHS of (6.15) can be absorbed by the one in the LHS for an appropriate  $\gamma$ . This concludes the analysis of  $R_{17}(t)$ .

The following terms can be controlled using the inverse inequality and Young's inequality:

$$\begin{aligned} R_{18}(t) &\lesssim \beta(1 - \beta)\gamma\alpha_u \mu (\|\nabla^s E\| + \|\nabla^s \Lambda\|) \|\nabla^s (P_{u,0}[\nabla G])\|, \\ R_{19}(t) &\leq (1 - \beta)\gamma\alpha_u (\|F\| + \|\Gamma\|) \|\nabla^s (P_{u,0}[\nabla G])\|. \end{aligned}$$

To see that the bounds obtained fall within the structure (6.6) we have to use the expression of the stabilisation parameter  $\alpha_u$  to check that  $\mu h^{-2} \lesssim \alpha_u^{-1}$  and take  $\gamma$  small enough to balance  $\xi^{-1}$ , which may need to be large.

The next terms to consider come from the stabilisation:

$$\begin{aligned} R_{20}(t) &= (1 - \beta)\gamma\alpha_u^2 \left( P_u^\perp[\rho \hat{u}_h \cdot \nabla (u_h - \mathcal{U} + \mathcal{U})], P_u^\perp[\rho \hat{u}_h \cdot \nabla (P_{u,0}[\nabla G])] \right), \\ R_{21}(t) &= (1 - \beta)\gamma\alpha_u \alpha_p \left( P_p^\perp[\nabla \cdot (u_h - \mathcal{U} + \mathcal{U})], P_p^\perp[\nabla \cdot (P_{u,0}[\nabla G])] \right), \\ R_{22}(t) &= (1 - \beta)\gamma\alpha_u \alpha_\sigma \left( P_\sigma^\perp \left[ (1 - \beta)\nabla^s (u_h - \mathcal{U} + \mathcal{U}) - \frac{\lambda}{2\mu} \hat{u}_h \cdot \nabla (\sigma_h - \Sigma + \Sigma) \right], P_\sigma^\perp[\nabla^s (P_{u,0}[\nabla G])] \right), \\ R_{23}(t) &= (1 - \beta)\gamma\alpha_u \alpha_\sigma \left( P_\sigma^\perp \left[ \frac{\lambda}{2\mu} g(\hat{u}_h, \hat{\sigma}_h) \right], P_\sigma^\perp[\nabla^s (P_{u,0}[\nabla G])] \right). \end{aligned}$$

All these terms can be bounded using a similar strategy as before.

With this we conclude the analysis of the last term in (6.8) (or in (6.9)). The second term,  $S(t)$ , is easy to treat: after using Young's inequality, the first term that arises can be absorbed by  $Q(t)$  and the second bounded as in (6.12). We have written  $S(t)$  independently to emphasise that it arises because of the linearisation of the rotational term: since we evaluate it with  $\hat{u}_h$  and  $\hat{\sigma}_h$ , it does not contribute to stability (that is to say, its contribution does not appear in  $Q(t)$ ). We could however have considered it as one more  $R_j(t)$  term.

It only remains to deal with the convective terms  $N(t)$  in (6.8). The first two of these terms can be written as follows:

$$\begin{aligned} & \rho(1 - \beta) (\tilde{c}(u, u, E) - \tilde{c}(\hat{u}_h, u_h, E)) \\ &= \rho(1 - \beta) (\tilde{c}((u - \hat{u}_h), u, E) - \tilde{c}((u - \hat{u}_h), \Lambda, E) + \tilde{c}(u, \Lambda, E)). \end{aligned} \quad (6.17)$$

The three RHS terms of the above equation can be easily bounded fitting the structure (6.6)-(6.7).

A similar procedure can be applied to the convective terms arising from the constitutive equation, which can be written as:

$$\frac{\lambda}{2\mu} (\tilde{c}(u, \sigma, F) - \tilde{c}(\hat{u}_h, \sigma_h, F)) = \frac{\lambda}{2\mu} (\tilde{c}((u - \hat{u}_h), \sigma, F) - \tilde{c}((u - \hat{u}_h), \Gamma, F) + \tilde{c}(u, \Gamma, F)).$$

The remaining convective terms to be controlled in the LHS of (6.8) can be written as

$$\begin{aligned} & (1 - \beta) \gamma \alpha_u \rho (\tilde{c}(u, u, P_{u,0} [\nabla G]) - \tilde{c}(\hat{u}_h, u_h, P_{u,0} [\nabla G])) \\ &= (1 - \beta) \gamma \alpha_u \rho (\tilde{c}(u - \hat{u}_h, u, P_{u,0} [\nabla G]) - \tilde{c}(u - \hat{u}_h, u - u_h, P_{u,0} [\nabla G]) + \tilde{c}(u, u - u_h, P_{u,0} [\nabla G])). \end{aligned}$$

The strategy to bound these terms is similar to what we have used heretofore.

This concludes the proof of the third step.

**Step 4. Fixed point theorem .** According to Step 3, the ball  $\mathcal{B}_h$  is invariant under the map  $\delta$ , that is to say,  $\delta(\mathcal{B}_h) \subset \mathcal{B}_h$ . Therefore, applying Schauder's fixed point theorem we conclude that there exists  $(u_h, p_h, \sigma_h) \in \mathcal{B}_h$  such that  $(u_h, p_h, \sigma_h) = \delta(u_h, p_h, \sigma_h)$ , which, in view of the definition of  $\delta$ , implies that  $(u_h, p_h, \sigma_h)$  is a solution of (4.1). Because of the definition of  $\mathcal{B}_h$  in (6.2), we also obtain an error estimate.  $\square$

## 7. Conclusions

In this article we have presented the numerical analysis of a stabilised finite element approximation proposed to solve viscoelastic fluid flows, in the nonlinear time-dependent case. This analysis has confirmed the numerical results obtained in other works, where the method was proposed and tested in nonlinear examples. In particular, we have shown this using a fixed point theorem under suitable regularity conditions in velocity, stress and pressure. As it is usual for nonlinear problems involving the Navier-Stokes equations, the estimates do not show information about their behaviour when the local Reynolds and Weissenberg numbers increase. On the other hand, some control over the pressure, although very weak, has been obtained.
